

DAWSON CITY COUNCIL MEETING
JULY 02, 2018 @ 7:00 P.M.
114 N. MAIN ST. DAWSON, TX. 76639

Mayor Sanders called the meeting to order at 7:00 P.M. Council present were: Stephen Sanders, Aaron Hogue, Darrell Stevenson, and Greg Hall. Council absent from the meeting was Tony Mikeska and Cameron Shaw. Employees present were: Ronda Franks, Violet Bumpers, Michael Carter, Chris Foley and Josh Burleson.

Violet gave the Municipal clerk report for June. She collected \$9,682.63 of which the state gets \$3,521.81 and the city gets \$6,160.82.

Council agreed to let **Ray Rogers trench the water line** from Hugh Ellis property to where the new house will be and the city lays the pipe then Mr. Rogers can cover it up.

Ronda is to add the Penalty paragraph to the Fireworks Ordinance 2016-3.

Aaron made a motion to appoint **Mayor Sanders designated signee** for the **PD grant**. **Darrell** seconded the motion, all in favor motion passed.

Aaron made a motion for the fine amount, for Dogs at Large, to be \$200.00 plus \$100.00 fee for taking animals to the pound in Corsicana Ordinance 2013-9A. **Darrell** seconded the motion all in favor motion passed.

Darrell made a motion to approve the June 04, 2018 Minutes. **Greg** seconded the motion all in favor motion passed.

Aaron made a motion to approve the Financial report. **Greg** seconded the motion all in favor motion passed.

Greg made a motion to approve Paying of the Bills subject to inspection. **Darrell** seconded the motion all in favor motion passed.

Ronda let the council know that as of October 01, 2018 the **City of Corsicana** will be going up on their water rates by .35 cents per thousand. The city will increase the water rates by .35 per thousand as per the August 10, 2015 minutes stating that anytime a vendor goes up on their rates the city will do the same.

Council told **Ronda** that on **new water/sewer taps** if the customer has paid their 200.00 deposit to start bill immediately once tap is done. If they have not paid the 200.00 deposit keep the new meter locked until paid. If person doesn't want to turn the meter on at the time of the tap refund deposit and lock meter.

Aaron made a motion to hire **Robert Kemp Sr.** at \$12.00/hr and work 20 hours per week. **Greg** seconded the motion, all in favor motion passed.

Ronda let council know that to do **direct deposit with payroll** it will cost \$1.75 per check per occurrence. Council said **no direct deposits**.

Darrell made a motion to adjourn the meeting since there is no further business to discuss. **Aaron** seconded the motion, all in favor motion passed.
