Mayor Sanders called the meeting to order at 7:00 P.M. Council present were: Stephen Sanders, Kelly Jankowski, Darrell Stevenson, Tony Mikeska and Cameron Shaw. Council discussed the quote from Radco for repairing the garage area beam. The quote was for \$830.00. **Cameron** made a motion to have Radco repair the beam. **Tony** seconded the motion all in favor motion passed.

Darrell made a motion to approve the October 03, 2016 Minutes. **Tony** seconded the motion all in favor motion passed.
