

**MINUTES FOR THE SPECIAL CALLED DAWSON CITY COUNCIL MEETING  
AUGUST 18, 2020 @ 6:00 P.M.

CALL MEETING TO ORDER AT 6:03PM.

COUNCIL MEMBER PRESENT WERE: MAYOR STEPHEN SANDERS, DARRELL STEVENSON, MAYOR PRO-TEM BARBARA L. ADLER, CHARLES RAINES, AARON HOGUE AND CAMERON SHAW. EMPLOYEE PRESENT WAS RONDA FRANKS.

DISCUSS AND ESTABLISH **PROPERTY TAX RATE FOR 2020**. **DARRELL** MADE A MOTION TO ESTABLISH THE \$0.419/\$100 AS THE TAX RATE FOR 2020. **CAMERON** SECONDED THE MOTION. ALL IN FAVOR. MOTION PASSED.

DISCUSS AND POSSIBLY ACT UPON **BOND OFFER**. BARBARA PRESENTED 3 BOND PROPOSALS TO THE COUNCIL, 2.5 MILLION BOND, 2.25 MILLION BOND AND A 2 MILLION BOND. BARBARA EXPLAINED THAT THE PURPOSE FOR THE BOND WOULD BE TO GRIND/RE-PACK BASE/ CHIP SEAL ALL CITY STREETS, EXCLUDING THE ONES MAINTIANED BY THE STATE AND/OR COUNTY. TO ALSO, REMODEL CITY OFFICES, COUNCIL ROOM, COURTROOM AND POLICE OFFICES, NEW ROOF SYSTEM, NEW FURNITURE. LARGER DUMP TRAILER 20', MOWING TRACTOR WITH IMPLEMENTS. PLACE AN OFFICE AT WATERTOWER OR SEWER PLANT WITH BATHROOM & SHOWER 20 X 20, DITCH DIGGER AND MINI EXCAVATOR. OBVIOUSLY THE LESS MONEY IN THE BOND THE LESS OF THE ITEMS GET DONE. **CAMERON** MADE A MOTION TO PROCEED WITH INFORMATION FLYER FOR THE CITIZENS AND REGISTERED VOTERS WITHIN THE CITY LIMITS. **DARRELL** SECONDED THE MOTION. ALL IN FAVOR, MOTION PASSED.
